TEAM LIABILITY RELEASE AND WAIVER AGREEMENT

(Page 3 of 3)

1. VOLUNTARY PARTICIPATION.

ALL team members and the name of team listed on Page 2 of 3 have acknowledged that each team member is voluntarily participating in the **12th Annual South Florida Dragon Boat Festival** (the "event") to be held on **October 4, 2014** in the areas of Intracoastal Waterway, Haulover Beach Park & Marina, Miami Beach (referred to as the "premises").

2. ASSUMPTION OF RISK.

Each team member is aware that dragon boat racing; entering the premises used for the purpose of launching, docking and storing equipment used in the sport of dragon boat racing; and participating in the United Chinese Association of Florida races and practice sessions held at the premises along with related activities are hazardous activities. Each team member is voluntarily participating in all and not limited to of these activities with full knowledge of the danger involved and hereby agree to accept any and all risks of injury or death associated with these activities and verify this statement by signing on Page 2 of 3 -- TEAM ROSTER and SIGNATURES for Team Liability Release and Waiver Agreement.

3. RELEASE.

As consideration for being permitted by the United Chinese Association of Florida (the "Organizer") or one of its affiliated organizations to participate in these activities and use the facilities and premises in connection with the activities, the team member hereby agree that he/she, his/her assignees, heirs, distributees, guardians, and legal representatives will NOT make any claim against, sue or attach the property of the United Chinese Association of Florida, the Miami-Dade County Park & Recreation Department or any of their affiliated organizations, their respective directors, members, trustees, agents, representatives, officers, employees, servants, sponsors, licensors or authorized representatives (the "Released Parties") for injury or damage resulting from the negligence or other acts, howsoever caused, by a Released party as a result of his/her participation in the activities, including Dragon Boat Racing. The Team member hereby releases the Released Parties and any of their affiliated organizations from all actions, claims or demands that he/she, his/her assignees, heirs, distributees, guardians and legal representatives now have or may hereafter have for injury or damage resulting from his/her participation in the activities, including dragon boat racing.

Further, the team member agrees and grants to the Organizer, exclusive right to use, publish or reproduce any photographs, drawings, writings or any copyrightable material produced of him/her or by him/her as a voluntary participant of the event.

The team member is aware that this is a release of liability and a contract between him/herself and the Organizer and any/or all of its affiliated organizations and sign it of the team member's own free will.
